SUBJECT: Correction of Military Record, Airman Basic [REDACTED]

1. Recommend [REDACTED] be awarded the rank of Airman (E-2) as of 19 March 1997 and receive appropriate back pay. [REDACTED] had completed 2 years of JROTC prior to enlisting and meets requirements for increased rank/pay grade to Amn/E-2.
2. When [REDACTED] Air Force Reserve Recruiting was unaware of a change authorizing enlistment of 2-year JROTC members at the grade of E-2. Apparently, the instruction authorizing this change (DOD Instruction 1205.13, 26 December 1995), was not coordinated through HQ USAF/DPXFA in a timely manner. As a result, we didn't receive notice of the change until 4 June 1997. We regret this error took place.
3. This information was coordinated with the OL CV AFRRCS senior recruiter located at Pittsburgh, PA and HQ USAF/DPXFA.
