

SUBJECT: Request Written Comments—Correction of Military Records [REDACTED]

The attached Application for Correction of Military Records submitted by [REDACTED] a member of the [REDACTED] Air National Guard is forwarded for your comments.

The applicant requests his date of rank to Major (04) reflect Jun of 96 the date the applicant became eligible for promotion through unit vacancy. This Headquarters recommends relief be granted. The official military records of the applicant should be changed to reflect promotion to Major (04) with a promotion effective date and promotion service date of 20 Jun 96. The applicant should be also entitled to all back pay and allowance from 20 Jun 96 to the present.

It is evident that the [REDACTED] Logistics Commander selected the applicant for the Logistics Support Flight Commander position in May of 96 and had intended to promote the applicant via position vacancy. Due to an incomplete selection folder, the applicant was considered by a mandatory promotion board and non-selected for promotion. This error has been corrected by a Special Selection Board.
