MEMORANDUM FOR THE CHIEF OF STAFF

Under the authority of Section 1552, Title 10, United States Code and Air Force Instruction 36-2603, and having assured compliance with the provisions of the above regulation, the decision of the Air Force Board for Correction of Military Records is announced, and it is directed that:

The pertinent military records of the Department of the Air Force relating to [REDACTED], be considered for promotion to the grade of major, Air Force Reserve, by a Special Review Board; that her records be evaluated in comparison with the records of officers who were and were not selected by the FY 1997 Reserve of the Air Force Major Selection Board, which convened on 4 March 1996, and if she is recommended for promotion by a Special Review Board, the Air Force Board for Correction of Military Records be advised of that recommendation at the earliest practicable date so that all necessary and appropriate actions may be taken.

If she is not recommended for promotion by the Special Review Board, the office of primary responsibility advise her of the recommendation of the Special Review Board.

1. The requested correction cannot be accomplished administratively at this headquarters.

2. The applicant requests her Date of Rank (DOR) be moved to reflect a promotion to major during the FY97 Major Selection Board.

3. The following is an analysis of the case:

a. The applicant was considered but not selected by the FY97 Reserve of the Air Force Major Selection Board, which convened at this headquarters on 4 March 1996. She was subsequently considered and selected by the FY98 Reserve of the Air Force Major Selection Board which convened at this headquarters on 3 March 1997.

b. The applicant states that her **Officer** Performance Report (OPR) which closed out 2 December 1995, and her previous OPRs and awards she received while on active duty were not reviewed by the **Major** Selection Board on 4 March 1996.

c. A review of her selection folder determined that the date of the OPR was actually 4 December 1995 and that it was the only document reviewed by the board. Her previous OPRs and awards from active duty were not in her record.

4. Recommend approval of a Special Review board (SRB).

5. If the AFBCMR agrees with our recommendation, the applicant should be granted an SRB in lieu of the FY97 Major Selection board. If selected by the SRB, she should receive a DOR and promotion effective date of 28 February 1996. Back pay and allowances would need to be adjusted as appropriate. If not selected by the SRB, no further action is required.

6. If the AFBCMR disagrees with our recommendation, no further action is required.
