SUBJECT: Application for Correction of Military Records - [REDACTED]

Requested Action and Basis for Request: Retroactive approval and reimbursement of overseas station allowances for dependents remaining at the member's previous duty station, and dependent travel expenses from overseas to [REDACTED]

Facts: Member contends he was not properly counselled by officials at [REDACTED] that he was required to submit a formal request for continuation of station allowances prior to [REDACTED] departure from the overseas area. [REDACTED] was assigned to [REDACTED] from 21 Jan [REDACTED] and departed there on 30 Aug [REDACTED]

Discussion: Member was married on 28 Jul [REDACTED], attempted to obtain approval for command sponsorship, but was told this was unnecessary. However, [REDACTED] son was command sponsored on 4 Apr [REDACTED]. His spouse and child were unable to travel with the member when he departed the overseas area, because the spouse was unable to obtain an immigration visa until 2 Mar [REDACTED] and spouse and child arrived in the United States on 13 Mar [REDACTED]. Also, the member used his personal funds to purchase airline tickets for his spouse and child to travel from the [REDACTED]

Recommendation: The member has provided the necessary documentation to support his claim of miscounselling by officials at his former overseas base of assignment. Recommend member's records be changed to authorize reimbursement of overseas station allowances, at the with-dependent rate, while the dependents resided in the vicinity of [REDACTED] for the period 4 Apr [REDACTED] through 13 Mar [REDACTED]. Also, recommend member's records be changed to authorize reimbursement of travel expenses from the [REDACTED]
