REVIEW OF NAVAL RECORD

1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to establish entitlement to a zone "B" Selective Reenlistment Bonus (SRB) for the ET rating (NEC 1571).

2. The Board, consisting of Mr. Pfeiffer, Mr. Tew, and Ms. Moidel, reviewed Petitioner's allegations of error and injustice on 17 August 1999 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

## **RECOMMENDATION:**

That Petitioner's naval record be corrected, where appropriate, to show that:

a. The following extensions are null and void: 22 months, operative date on or about 1 September 1996; 5 months, operative date on or about 1 July 1998; 7 months, operative date on or about 1 July 1999.

b. He was discharged on 31 August 1996 and reenlisted on 1 September 1996 (prior to passing through zone "B"). The term is 6 years.

c. The above changes will entitle member to a zone "B" SRB, award level 1.5, for the ET rating (NEC 1571).

d. That a copy of this Report of Proceedings be filed in Petitioner's naval record.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
