REVIEW OF NAVAL RECORD

1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to establish entitlement to a zone "A" Selective Reenlistment Bonus (SRB) for the ETSW rating.
2. The Board, consisting of Mr. Kastner, Mr. Mazza, and Ms. McCormick, reviewed Petitioner's allegations of error and injustice on 25 May 1999 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
 - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
 - b. In correspondence attached as enclosure (2), Petitioner submitted documentation showing that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.


RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. The reenlistment executed on or about 19 May 1998 is for 2 years, vice 4 years. Member reenlisted under the PRISE III program.
- b. The 24 month extension, operative date on or about 20 May 2000, is null and void.
- c. He was discharged on 31 March 1999 and reenlisted on 1 April 1999 (graduation date). The term is 4 years.
- d. The above changes will entitle member to a zone "A" SRB, award level 4.5, for the ETSW rating.
- e. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


