1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Petitioner is entitled to per diem for the period he was attending the Personnel Officer Course at Camp Lejeune, NC.
2. The Board, consisting of Messrs. Kastner, Neuschafer, and Taylor, reviewed Petitioner's allegations of error and injustice on 1 August 2000 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
  - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
  - b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

#### CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. The second endorsement dated 18 February 1999 to CMC message issued on 110802Z January 1999 did not include the Petitioner's reassignment data. The orders did contain the statement that the end assignment would be furnished on graduation from the Personnel Officer Course.

b. Petitioner did not sign in with the 2d Marine Division when reporting to Camp Lejeune, NC to attend the Personnel Officer Course. He reported directly to the Marine Corps Service Support School, Camp Lejeune, NC (MCC K78) for TEMIS Personnel Officer Course 01-99.

c. Petitioner graduation from the Personnel Officer Course on 16 July 1999 and the appropriate naval authorities issued a follow-on endorsement on 16 July 1999 to direct Petitioner to report to the 2d Marine Division for permanent duty. End assignment orders could not be issued until after Petitioner graduated from the Personnel Officer Course.

d. Petitioner occupied the BOQ during the period of TAD but did not utilize the government dining facilities.

(NOTE: Petitioner should go to the closes facility which can compute travel vouchers and ask them to compute monies due for this action. Petitioner must present to the Agency computing the money due a copy of all previous vouches pertaining the period of TAD, any vouchers pertaining to the PCS move, and a copy of this action. **The Agency making the computation will not make the actual.** Petitioner will then forward the computation of monies due, a copy of this letter and all other vouchers pertaining to the TAD and PCS move to DFAS-DE/FYCC 6760 E. Irvington Place, Denver, CO 80279-7100.)

e. That a copy of this Report of Proceedings be filed in Petitioner's naval record.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
