1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that his naval record be corrected to show that he was retained on active duty during the 8 May-12 November 1999 period.
2. The Board, consisting of Mses. Davies and Schnittman and Dr. Schultz reviewed Petitioner's allegations of error and injustice on 21 June 2001 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
  - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
  - b. Enclosure (1) was filed in a timely manner.
  - c. In correspondence attached as enclosure (2), the Deputy Director, Reserve Affairs Division, Headquarters, U.S. Marine Corps, recommended that Petitioner's request be granted.


**CONCLUSION:**

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

**RECOMMENDATION:**

- a. That Petitioner's naval record be corrected to show that was not released from active duty on 13 May 1999, and that he was retained on active-duty from that date to 12 November 1999.
  - b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
