Dear Gunnery Sergers

This is in reference to your application for correction of your naval record pursuant to the provisions of title 10 of the United States Code, section 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 30 August 2001. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your 'naval record and applicable statutes, regulations and policies. In addition, the Board considered the report of the Headquarters Marine Corps Performance Evaluation Review Board (PERB), dated 1 June 2001, a copy of which is attached.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice. In this connection, the Board substantially concurred with the comments contained in the report of the PERB. In view of the above, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official

records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.

MEMORANDUM FOR THE EXECUTIVE DIRECTOR, BOARD FOR CORRECTION OF NAVAL RECORDS

- Subj: MARINE CORPS PERFORMANCE EVALUATION REVIEW BOARD (PERB) ADVISORY OPINION ON BCNR APPLICATION IN THE CASE OF GUNNERY SERGEANT
- Ref: (a) GySgt. DD Form 149 of 12 Feb 01 (b) MCO P1610.7E

 Per MCO 1610.11C, the Performance Evaluation Review Board, with three members present, met on 3 May 2001 to consider Gunnery Sergean petition contained in reference (a). Removal of the fitness report for the period 990312 to 990603 (TR) was requested. Reference (b) is the performance evaluation directive governing submission of the report.

2. The petitioner states that the report contained in his official military personnel file is not the same as the one he was provided upon his departure from Okinawa. He points out that there are differences in Section A (Duty Assignment), Section C (Billet Accomplishments), Section E1 (Courage), and H1 (Evaluations). To support his appeal, the petitioner furnishes a copy of the report he was provided.

3. In its proceedings, the PERB concluded that the report is both administratively correct and procedurally complete as written and filed. Although the Reporting Senior may have authored an earlier version of the report, that does not somehow invalidate the official report of record. What it appears to indicate is that after reviewing the completed document, the Reporting Senior noticed some inaccuracies and effected the necessary corrections. Of specific note is that Section H1 for enlisted Marines is to be marked "NO" since, with few exceptions, they do not serve as reporting officials. Simply stated, the Board discerns absolutely no error or injustice.

4. The Board's opinion, based on deliberation and secret ballot vote, is that the contested fitness report should remain a part of Gunnery Sergeant for official military record.
