1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show the reenlistment executed on or about 26 October 1999 is for a term of 2 years, vice 4 years.

2. The Board, consisting of Messrs. Novello, Pfeiffer, and Taylor, reviewed Petitioner's allegations of error and injustice on 6 November 2001 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), Petitioner submitted documentation showing that the request has merit and warrants favorable action.

#### CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. The reenlistment executed on or about 26 October 1999 is for 2 years, vice 4 years. Member reenlisted under the provisions of the PRISE III program.


b. He was discharged on 10 February 2000 and reenlisted on 11 February 2000 (graduation date from "A" school). The term is 6 years.

c. The above changes will entitle member to a zone "A" SRB, award level 3.0, for the STG rating.

d. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


