1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show advanced to paygrade E-4 effective 16 September 2001.
2. The Board, consisting of Messrs. Pfeiffer, Zsalman, and Ms. Hare, reviewed Petitioner's allegations of error and injustice on 30 October 2001 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
 - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
 - b. After reviewing the correspondence attached as enclosure (2), the Board concluded that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. Petitioner was advanced to paygrade E-4 effective 16 September 2001. (NOTE: Servicemembers taking the February/March 2001 Exam are advanced starting 1 July through 31 December 2001. Petitioner should have been advanced on 16 September 2001 based on his Final Multiple Score. Petitioner was not eligible to enlist in paygrade E-4 on 24 May 2001 because servicemembers are advanced from 1 July 2001 through 31 December 2001 from the February 2001 Exam.).

b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
