This is in reference to your application for correction of your naval record pursuant to the provisions of title 10 of the United States Code, section 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 27 March 2001. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your naval record and applicable statutes, regulations and policies. In addition, the Board considered the advisory opinion furnished by BUPERS memorandum 1160 PERS 815 of 1 March 2001, a copy of which is attached.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice. In this connection, the Board substantially concurred with the comments contained in the advisory opinion. Accordingly, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.

- 1. In response to reference (a), recommend no change to the petitioner's request.
- a. The petitioner reenlisted on 09 August 1999 for four years and received the zone "B" SRB maximum of \$30K for the FC rate.
- b. The petitioner requests to change the zone "B" reenlistment date to June 2000 upon successful completion of NEC 1335 "C" training and receive the SRB entitlement at the higher award level of 4.5 vice 4.0. However, the petitioner's ADSD is 12 December 1989 the member passed through the zone "B" window on 11 December 1999.
- c. Reference (b) listed the zone "C" SRB entitlement for NEC 1335 at award level 0.5 upon the date of the petitioner's completion of "C" school training.
- d. The petitioner is not eligible for a zone "B" SRB reenlistment in June 2000.
- 2. In view of the above, recommend the petitioner's record remain as is.
