This is in reference to your application for correction of your naval record pursuant to the provisions of title 10 of the United States Code, section 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 19 March 2002. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your naval record and applicable statutes, regulations and policies. In addition, the Board considered the advisory opinion furnished by NPC memorandum 1160 PERS 811 of 13 December 2001, a copy of which is attached.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice. In this connection, the Board substantially concurred with the comments contained in the advisory opinion. Accordingly, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.

1. In response to reference (a), recommend disapproval of the petitioner's request.

a. The petitioner reenlisted on 21 February ¹⁹⁹¹ 2001 to incur sufficient obligated service to accept and execute PCS orders to "C" school and follow-on assignment to PRECOMM duty.

b. The petitioner's is requesting SRB based on earning NEC 0431 in 1991. The petitioner had held NEC 0431 since March 1984. Additionally, the petitioner earned NEC 0430 in December 1991.

c. At the time of the petitioner's reenlistment on 21 February 1991, reference (b) was in effect. It listed neither STG - 0430 or STG - 0431 as SRB eligible.

d. At the time of the petitioner's requested reenlistment date, 21 February 1993, reference (c) was in effect. It also listed neither STG - 0430 or STG - 0431 as SRB eligible.

2. In view of the above, recommend disapproval of the petitioner's request.
