1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show advanced when first eligible.

2. The Board, consisting of Messrs. Cooper, Pfeiffer, and Zsalman, reviewed Petitioner's allegations of error and injustice on 19 August 2003 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. After reviewing the correspondence attached as enclosure (2), the Board concluded that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

## **RECOMMENDATION:**

That Petitioner's naval record be corrected, where appropriate, to show that:

a. Petitioner was advanced to paygrade E-3 effective 16 May 1990, E-4 effective 16 December 1991 and E-5 effective 16 December 1992 which was under the provision of a STAR contract on 2 July 1992.\

b. That part of the request for paygrade E-6 to be backdated was denied, in that, Petitioner's Final Multiple Score for paygrade E-6 did not meet any of the Final Multiple Scores required to be advanced during the period Petitioner would have been eligible by virtue of backdating the effective date of paygrade E-5.

c. That a copy of this Report of Proceedings be filed in Petitioner's naval record.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
