REVIEW OF NAVAL RECORD

1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show entitlement to a \$2,000.00 Enlistment Bonus (EB) College Kicker vice a \$1,000.00 College Kicker based on the completion of the required number of college credits along with enlistment in paygrade E2.
2. The Board, consisting of Messrs. Agresti, Neuschafer, and McBride, reviewed Petitioner's allegations of error and injustice on 28 October 2003 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
 - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
 - b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION


Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show entitlement to a \$2,000.00 EB College Kicker vice a \$1,000.00 EB College Kicker in conjunction with his enlistment of 10 December 2002 and further show advancement to paygrade E2 effective 10 December 2002.

a. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


