Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Petitioner was entitled to Basic Allowance for Housing (BAH) for Petitioner's actual duty station, i.e., where she was working vice BAH for place of assignment for personnel support purposes.
- 2. The Board, consisting of Messrs. Frankfurt, Kim, and Pfeiffer, reviewed Petitioner's allegations of error and injustice on 9 September 2003 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. After reviewing the correspondence attached as enclosure (2), the Board concluded that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

## **RECOMMENDATION:**

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. BuPers order 1161 was modified to show that Petitioner was assigned to the Personnel Support Detachment. It for personnel support purposes with permanent duty stated.
- h. Petitioner was authorized BAH for her permanent duty station which was Maritime for the period .

  - c. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
