1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Enlistment Bonus for College Credit (EBCC) entitlement.
2. The Board, consisting of Mr. Haney, Mr. Shy, and Ms. McCormick reviewed Petitioner's allegations of error and injustice on 26 September 2006 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
 - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
 - b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. Petitioner's enlistment on 13 September 2005 reflect an EBCC in the amount of \$8,000 under the provisions of CNRC GENADMIN 041436Z OCT 04.

b. Annex B (NAVCRUIT 1133/52) to Petitioner's DD Form 4 executed on or about 27 January 2005 reflect an \$8,000 EBCC.

c. Annex B (NAVCRUIT 1133/52) to Petitioner's DD Form 4 dated 20 March 2006 is null and void.

d. A copy of this Report of Proceedings be filed in Petitioner's naval record.


