


This is in reference to your application for correction of your naval record pursuant to the provisions of 10 USC 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 3 October 2006. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your naval record and applicable statutes, regulations and policies. In addition, the Board considered the advisory opinion furnished by NPC memorandum 1780 Pers 352G of 16 August 2006, a copy of which is attached.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice. In this connection, the Board substantially concurred with the comments contained in the advisory opinion. Accordingly, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.

1. The following is provided in response to reference (a). Recommend denial of [REDACTED]'s request to enroll in the Montgomery GI Bill (MGIB) Program. Since [REDACTED] did not provide substantial evidence to support his claim of misinformation, there is insufficient reason to recommend approval of his request. A review of [REDACTED] master digital record indicates he disenrolled from the MGIB Program on 31 July 1987. Per reference (b), the decision to disenroll is irrevocable. Additionally, members like [REDACTED], who initially declined MGIB Program enrollment, had a second opportunity to enroll during an open enrollment period, which occurred 1 December 1988 through 30 June 1989. Unfortunately, [REDACTED] did not enroll in the MGIB Program during either opportunity.
