1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Petitioner is entitled to Basic Allowance for Housing (BAH) for his prior duty station.

2. The Board, consisting of Messrs. Haney, Pfeiffer, and Ms. McCormick, reviewed Petitioner's allegations of error and injustice on 26 September 2006 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

#### CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. NPC modified the orders that reassigned Petitioner from USNA, Annapolis, MD to the NSGA, Fort Meade/DIO ISSP, Ft Meade, MD to include the statement that "Petitioner was not authorized travel of dependents or shipment of HHG at government expense from Annapolis, MD to Ft Meade, MD". The orders were modified to include the statement because the Petitioner was reassigned within the same geographical area.

b. Petitioner was authorized BAH for his prior duty station effective 16 April 2004. The prior duty station was USNA, Annapolis, MD 21402-5000.

c. A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
