1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that his naval record be corrected to show that he was discharged pursuant to the findings of the Physical Evaluation Board that he was not physically qualified for service, vice by reason of a condition, not a disability.

2. The Board, consisting of Messrs. W. [REDACTED] and [REDACTED], reviewed Petitioner's allegations of error and injustice on 18 December 2008 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Enclosure (1) was filed in a timely manner.

c. In correspondence attached as enclosure (2), the Commandant of the Marine Corps recommends that Petitioner's request be granted.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

a. That Petitioner's naval record be corrected to show that on 17 December 2002, he was discharged by reason of physical disability that existed prior to service, and assigned a separation code of JFM1 and a reentry code of RE-3P.

b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


