1. Pursuant to the provisions of reference (a), Petitioner, a former enlisted member of the Marine Corps Reserve, filed enclosure (1) with this Board requesting, in effect, that his record be corrected to show that he transferred to the Marine Corps Retired Reserve vice being discharged on 1 August 2000.

2. The Board, consisting of Mr. [REDACTED], Mr. [REDACTED] and Mr. [REDACTED] reviewed Petitioner's allegations of error and injustice on 23 March 2010 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to waive the statute of limitations and review the application on its merits.

c. Petitioner enlisted in the Marine Corps and was honorably released from active duty and transferred to the Marine Corps Reserve where he served until he was discharged on 1 August 2000.

d. With his application, Petitioner forwarded a copy of his statement of service showing over 21 years of qualifying service along with his verification letter from the Commandant of the Marine Corps (CMC) dated 18 March 2010, stating he had enough time to receive retired pay at age 60.

e. The Board did not request an advisory opinion in this case. However, the Board is aware that Commandant of the Marine Corps has routinely recommended corrective action when an individual is qualified for reserve retirement and was discharged prior to requesting transfer to the Retired Reserve.

f. The Uniform Retirement Date Act, 5 U.S.C. 8301, requires that the effective date of any retirement be the first day of the month following the date of separation.

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes that Petitioner's request warrants relief. He was in good standing in the Marine Corps Reserve and was credited with over 21 years of qualifying service. Therefore, the Board concludes that his record should show that he transferred to the Marine Corps Retired Reserve on 1 September 2000.


RECOMMENDATION:

a. That Petitioner's naval record be corrected to show that he transferred to the Marine Corps Retired Reserve effective 1 September 2000, in the rank of sergeant (Sgt/E-5), vice being discharged on 1 August 2000, now of record.


b. That this Report of Proceedings be filed in his naval record.
