1. Pursuant to the provisions of reference (a), Petitioner applied to this Board requesting his naval record to show that he was discharged from the Navy Reserve on 26 April 1998.

2. The Board, consisting of Mr. [REDACTED], Mr. [REDACTED], and Ms. [REDACTED], reviewed Petitioner's allegations of error and injustice on 25 August 2010 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2) the Commander Navy Personnel Command advised the Board, in effect, that Petitioner was discharged after the date he had requested. He recommends that Petitioner's request be granted.

CONCLUSION:

Upon review and consideration of all the evidence of record, and in view of the contents of enclosure (2) the Board finds the existence of an injustice warranting the following action.


RECOMMENDATION:

a. That Petitioner's naval record be corrected to show that he was discharged on 26 April 1998 vice 28 June 2002.

b. That a copy of this Report of Proceedings be filed in his naval record.
