REVIEW OF NAVAL RECORD

1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that he accepted his commission as a lieutenant in the Navy Reserve on 17 January 2008, rather than 29 July 2008, and that the lieutenant date of rank reflected on his commission was 1 June 2007, rather than 4 December 2007.

2. The Board, consisting of Messrs. Boyd, Spooner and Swarens, reviewed Petitioner's allegations of error and injustice on 21 July 2011, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In enclosure (2), the Navy Personnel Command office with cognizance over the subject matter of Petitioner's case has commented to the effect the request has merit and warrants favorable action.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error and injustice warranting the following corrective action.

RECOMMENDATION:

a. That Petitioner's naval record be corrected, where appropriate, to show he accepted his commission as a lieutenant in the Navy Reserve on 17 January 2008, rather than 29 July 2008.

b. That his anniversary date and pay entry base date be adjusted accordingly.

c. That his record be corrected further to show that the lieutenant date of rank reflected on his commission was 1 June 2007, rather than 4 December 2007; and that his lineal precedence be adjusted accordingly.

d. That any material or entries inconsistent with the Board's recommendation be corrected, removed or completely expunged from Petitioner's record and that no such entries or material be added to the record in the future.


e. That a copy of this Report of Proceedings be filed at an appropriate location in Petitioner's naval record, and that another copy of this report be returned to this Board, together with any material directed to be removed from Petitioner's record, for retention in a confidential file maintained for such purpose.

4.
