1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to establish entitlement to an Enlistment Bonus for College Credits (EBCC) and to remove the Seaman Career Track (S-PACT) Annex.

2. The Board, consisting of Mr. Zsalman, Mr. George, and Mr. Ruskin, reviewed Petitioner's allegations of error and injustice on 30 June 2014 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has partial merit and warrants partial favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board

finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. Undesignated and undated Annex to the DD Form 4 signed 7 July 2009 noting the Seaman Career Track (S-PACT) is now designated Annex B and dated "11 August 2008". This change establishes continuity in Petitioner's record.

b. Option (2) of Annex B to the DD Form 4 dated 11 August 2008 reflects "Enlistment Bonus for College Credits (EBCC) \$8,000 Bonus". All other enlistment guarantees remain the same.


c. The Navy Personnel Command (PERS-811), PSD Charleston, or Ballston Spa, New York will pay the EB entitlement as appropriate (provided all EB criteria have been met).

d Note: The Board found that relief to remove the Seaman Career Track (S-PACT) Annex is denied, because Petitioner reclassified from the Master-At-Arms (MA) program into the Seaman Career Track (S-PACT) program.

e. A copy of this Report of Proceedings will be filed in Petitioner's naval record.


4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
