1. Pursuant to the provisions of reference (a) Petitioner filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that Petitioner was advanced to E-4/STS3 from the March 2011 Navy-wide advancement exam.

2. The Board, consisting of Messrs. Zsalman, Ruskin and George reviewed Petitioner's allegations of error and injustice on 10 March 2014 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following

corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, as follows:


a. Petitioner was advanced to E-4/STS3 from the March 2011 Navy-wide advancement exam with an effective date of [REDACTED] with a Time In Rate date of [REDACTED]

Note: Due to the above correction, Petitioner was eligible to participate in the September 2012 E-5 exam. However, since the correction was not yet made, he was unable to participate in the exam. Therefore, he participated in the March 2013 E-5 exam and was selected for advancement. The March 2013 exam was then compared to the previous September 2012 exam but his final multiple was less than the minimum multiple required.

b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


