1. Pursuant to the provisions of reference (a) Petitioner filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that he was honorably discharged from the Naval Reserve effective 5 February 2004 vice 1 July 2010.
2. The Board, consisting of Messrs. Zsalman, George and Ruskin reviewed Petitioner's allegations of error and injustice on 11 August 2014 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
 - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
 - b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, as follows:

a. Petitioner voluntarily resigned his commission on 5 February 2004, the day after the end of the anniversary year of his most recent recorded participation in the Naval Reserves.

b. Petitioner's "failures to select" for promotion from FY 2006 through FY 2011 will be voided.

c. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


