1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to receive entry grade credit.

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 26 July 2016 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. The Officer Appointment Acceptance and Oath of Office (NAVPERS 1000/4), executed on or about 14 July 2014 is modified to read "block 13 (Permanent Grade) "LTJG" vice "ENS", block 14 (Perm grade date) "3 June 2012" vice "3 June 2014", block 15 (Present grade) "LTJG" vice "ENS", and block 16 (Present grade date) "3 June 2012" vice "3 June 2014". Note: Petitioner received 2 years of Medical Service Corps entry grade credit for obtaining a Master of Social Work degree from the University of [REDACTED] awarded on 20 December 2012.

b. Defense Finance & Accounting Service (DFAS) will complete an audit of Petitioner's records to determine if Petitioner is due any back pay and allowances.

c. A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
