1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected by removing the Evaluation Report covering the period of 16 March through 1 July 2013.
2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 23 January 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record.
