1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to change effective date of advancement to E4.

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 17 October 2016 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has partial merit and warrants partial favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following partial corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. The Petitioner's Examination Profile Information and Exam Status sheet from the September 2015 cycle 228 Navy Wide Advancement Exam (NWAE) is modified to read Final Multiple Score (FMS) is "120.31" vice "0.00".

b. That part of the Petitioner's request for corrective action that exceeds the foregoing is denied. After comparing March 2016 cycle 231 NWAE against September 2015 cycle 228 NWAE, Petitioner's FMS did not exceed the minimum FMS of 127.10 required to be advanced to SH3. Furthermore, the sailor is missing a transfer evaluation from her official military personnel file that could have been counted towards her Performance Mark Average (PMA).

c. A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
