1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to establish entitlement to retroactive Special Duty Assignment Pay (SDAP).

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 22 November 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

#### CONCLUSION

Upon review and consideration of all the evidence of record the Board finds that Petitioner's SDAP was not processed in a timely manner. In light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was entitled to SDAP while assigned as Nuclear Plant Supervisor (NEC 3363), onboard [REDACTED] from 2 July 2012 to 16 November 2012, at SDAP level SD-5 at the rate of \$375.00 per month.

Petitioner was entitled to SDAP while assigned as Nuclear Plant Supervisor (NEC 3363), onboard [REDACTED] from 19 December 2012 to 8 July 2016, at SDAP level SD-5 at the rate of \$375.00 per month.

Note: Petitioner earned a total of \$18,087.50 in SDAP between 2 July 2012 and 8 July 2016. However, of that total Petitioner has already been paid a total \$14,099.50. Request the final payment will be determined by Defense Finance and Accounting Services.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
