- 1. Pursuant to the provisions of reference (a), Petitioner, an enlisted member of the Marine Corps, filed enclosure (1) the Petitioner requested to remove (NAVMC 118(11)) Administrative Remarks (6105) entry dated 31 May 2016 from his Official Military Personnel File (OMPF).
- 2. The Board, consisting of allegations of error and injustice on 3 March 2017, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
  - b. Enclosure (1) was filed in a timely manner.
- c. Petitioner erroneously received an administrative remarks (6105) on 31 May 2016 per enclosure (3). The Administrative Remarks (6105) was placed in the Petitioner's OMPF pertained to EDIPI numbe
- d. HQMC provided a favorable advisory opinion in response to the Petitioner's claim per enclosure (4). The advisory opinion concluded that the Administrative Remarks (6105) uploaded to the Petitioner's OMPF is erroneous since it belonged to another member.

## CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concluded that Petitioner's request warrants relief in the form of removing from his record, the Administrative Remarks (6105) uploaded on 31 May 2016 per enclosure (3). In this regard, the Board found the advisory opinion furnished by Headquarters United States Marine Corps as credible sources for approval of Petitioner's claim.

In view of the above, the Board directs the following corrective action.

## RECOMMENDATION:

- a. That Petitioner's naval record be corrected by removing the Administrative Remarks (6105) uploaded on 31 May 2016.
- b. That any material or entries inconsistent with or relating to the Board's recommendation be corrected from Petitioner's record and that no such entries or material be added to the record in the future.
- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
