1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner was eligible for and received a Selective Reenlistment Bonus (SRB).

2. The Board, consisting of █, █ and █, reviewed Petitioner's allegations of error and injustice on 29 June 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 14 February 2012, Petitioner entered active duty.

c. On 11 December 2015, Petitioner reenlisted for 4 years with an EAOS of 10 December 2019.

d. On 11 May 2018, Petitioner signed an agreement to extend enlistment for 7 months with an SEAOS of 10 July 2020 in order to match EAOS with PRD.

e. On 2 January 2019, Deputy Chief of Naval Personnel notified Petitioner that he was authorized immediate in-rate reenlistment in the Active Component (AC) component with an end date of April 2020.

f. On 8 April 2020, Petitioner signed a NPPSC (Command Career Request) requesting a 4 year reenlistment effective 30 April 2020, and was approved by cognizant authority on 10 April 2020.

g. In accordance with reference (b) [30 April 2020], a zone "B" SRB with an award level of 1.0 (\$30,000 award ceiling) for the ABH rate was authorized with the following note: "The Navy Enlisted Classification (NEC) 0000, commonly referred to as quad zero, is listed here to establish that Sailors in these ratings/career fields can hold any or no NEC and still be qualified for the SRB provided they meet all."

h. On 30 April 2020, Petitioner reenlisted for 4 years with an EAOS of 29 April 2024.

i. On 2 July 2020, Petitioner transferred from [REDACTED]

j. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 30 April 2020, the date of Petitioner's reenlistment, reference (b) was released listing a zone B SRB with 1.0 award level. If the Command Career Counselor had notified the SRB desk on 30 April 2020, the SRB would have been approved.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's command submitted an OPINS/Navy Standard Integrated Personnel System (NSIPS), and was approved by cognizant authority.

Note: This change will entitle the member to a zone "B" SRB with an award level of 1.0 (\$30,000 award ceiling) for the ABH rate. Remaining obligated service to 10 July 2020 will be deducted from SRB computation.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
