1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his DD Form 4, Enlistment/Reenlistment Document be corrected to reflect Home of Record (HOR) as █ vice █

2. The Board, reviewed Petitioner's allegations of error and injustice on 1 July 2020, and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of enclosures (1) through (8), relevant portions of Petitioner's naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. In accordance with reference (b), a correction to the HOR may be authorized when, through a bona fide error, the place originally named at time of current entry into the Service was not in fact the actual home.

b. On 5 March 2019, Petitioner enlisted in the Naval Reserve for 8 years with a 4-year obligation in the Regular Component of the Navy. Enlistment documents reflect the following:

(1) DD Form 4, Enlistment/Reenlistment Document, block 3 (Home of Record) “[REDACTED]” and block 4 (Place of enlistment) “[REDACTED]”. See enclosure (2).

(2) DD Form 1966, Record of Military Processing, block 3 (Current Address) “[REDACTED]”, block 4 (Home of Record Address) “[REDACTED]”, block 14 (Valid Driver’s License) “[REDACTED]”, block 15 (Place of Birth) “[REDACTED]” and block 22 (Education) “[REDACTED]”. See enclosure (3).

c. Petitioner’s [REDACTED] State College Diploma and [REDACTED] State College Semester 2019 Program of Study indicate both schools are located in [REDACTED]. See enclosures (4) and (5).

d. Petitioner’s Active Duty Service Date is 6 August 2019 and his electronic service record indicates HOR as [REDACTED]. See enclosure (6).

e. On 29 June 2020, Navy Personnel Command (PERS-312) provided an unfavorable advisory opinion to enclosure (1). PERS-312 recommended disapproval of relief based on Petitioner failing “to provide evidence in error to correct the HOR”. See enclosure (7).

f. On 1 July 2020, BCNR forwarded PERS-312 advisory opinion to the Petitioner for his review and response. Petitioner did not provide a response. See enclosure (8).

BOARD CONCLUSION

Upon review and consideration of all the evidence of record, despite the contents of enclosure (7), the Board finds the existence of an error warranting corrective action in accordance with reference (b). The Board concluded Petitioner provided sufficient evidence to reflect HOR at time of enlistment was [REDACTED] vice [REDACTED].

BOARD RECOMMENDATION

That Petitioner’s naval record be corrected, where appropriate, to show that:

Petitioner’s DD Form 4, Enlistment/Reenlistment Document dated 5 March 2019 is amended to reflect block 3 (Home of Record) “[REDACTED]” vice “[REDACTED]”.

4. It is certified that a quorum was present at the Board’s review and deliberations, and that the foregoing is a true and complete record of the Board’s proceedings in the above-entitled matter.
