1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be correct to reflect retroactive advancement to Aviation Ordnanceman Chief (AOC)/E-7 effective September 2020 vice June 2021.

2. The Board, consisting of ██████████ and ██████████, reviewed Petitioner's allegations of error and injustice on 14 September 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. On 16 January 2011, Petitioner advanced to Aviation Ordnanceman First Class (AO1)/E-6) with at time in rate (TIR) date of 1 January 2011.

b. Petitioner was mobilized from 22 June 2012 through 1 October 2015 in support of ██████████.

c. On 17 August 2015, Petitioner was approved for augmentation to the active component (AC).

d. On 2 October 2015, Petitioner reenlisted in the AC for a term of 6-years.

e. Petitioner participated in AC Cycles [REDACTED], and [REDACTED] Navy Wide Advancement Examination (NWAE) and was board eligible but not selected for advancement.

f. In March 2020, Petitioner participated in [REDACTED] for AOC/E-7 and selected for advancement with an effective date of 16 June 2021.

g. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. Petitioner transferred from Reserve Component to AC effective 2 October 2015 without a break in service; therefore, the entries made in his record changing his AO1/E-6 date of rank from 16 January 2011 to 2 October 2015 and TIR from 1 January 2011 to 1 July 2015 are invalid. The Board concluded these erroneous entries delayed Petitioner's date of advancement to AOC/E-7 and felt under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner advanced to AO1/E-6 effective 16 January 2011 with a TIR date of 1 January 2011.
Note: All other entries in Petitioner's record regarding advancement to AO1/E-6 are to be removed.

This change amends Petitioner's advancement to AOC/E-7 effective "16 September 2020" vice "16 June 2021" with TIR date of 1 September 2020.

Note: Defense Finance and Accounting Service will complete an audit of Petitioner's records to determine retroactive pay and allowance entitlements.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing
