1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner reenlisted for a term of 5 years vice 6 years and was eligible for and received a Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Constant and Annual An**

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 5 July 2016, Petitioner entered active duty for 4 years with an end of active obligated service (EAOS) of 4 July 2020.

c. On 12 July 2018, Petitioner signed an agreement to extend enlistment for 9 months with a soft end of active obligated service (SEAOS) of 4 April 2021 in order to extend to match EAOS with projected rotation date (PRD) of April 2021.

d. In accordance with reference (b), this NAVADMIN announces revised SRB policy for Active Component (AC) and Full-Time Support (FTS), superseding NAVADMIN 272/19.

Subj: REVIEW OF NAVAL RECORD ICO XXX-XX-

Sailors must now reenlist within 365-days of their EAOS (as opposed to 270-days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who can reenlist at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

e. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 003/FY21) listed a zone "A" SRB with an award level of 2.0 (\$30,000 award ceiling) for the AO rate.

f. On 28 October 2020, COMNAVPERSCOM notified Petitioner's command that a zone "A" SRB with an award level of 2.0 for the AO rate was approved for a 5 year reenlistment effective 11 November 2020 based on pay grade E-4.

g. On 11 November 2020, Petitioner reenlisted for 6 years with an EAOS of 10 November 2026.

h. On 23 November 2020, COMNAVPERSCOM notified Petitioner's command that SRB was cancelled.

i. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Petitioner's reenlistment contract was prepared for a 6-year term vice 5-year term. Since the reenlistment contract term did not match the SRB authorization, the SRB was cancelled.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

The immediate reenlistment contract (NAVPERS 1070/601) executed on 11 November 2020 was for a term of 5 years, vice 6 years.

Note: This change will entitle the member to a zone "A" SRB with an award level of 2.0 (\$30,000 dollar award ceiling) for the AO rate. Remaining obligated service to 4 April 2021 will be deducted from SRB computation.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
