1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish 6-months of Entry Grade Credit (EGC).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 15 February 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

- a. Petitioner was employed at Sentara Healthcare from 25 June 2018 through 25 June 2019.
- b. On 19 July 2019, NAVCRUIT 1070/3, Medical Service Corps Entry Grade Credit Worksheet did not award Petitioner with EGC.
- c. On 30 September 2019, NAVCRUIT 1131/245, Memorandum of Understanding for Initial Date of Rank did not award Petitioner with EGC.
- d. On 30 September 2019, Petitioner signed NAVPERS 1000/4, Officer Appointment Acceptance and Oath of Office as an Ensign/O-1 with a date of rank of 19 July 2019.
- e. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. In accordance with reference (b), Petitioner met the eligibility criteria for 6-months of EGC based on employment with [REDACTED] Healthcare before commissioning; therefore, the Board felt, under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's NAVCRUIT 1070/3, Medical Service Corps Entry Grade Credit Worksheet dated 19 July 2019, is amended to reflect: Block 3 "00 years, 06 months, and 00 days" vice "00 years, 00 months, and 00 days."

Petitioner's NAVCRUIT 1131/245, Memorandum of Understanding for Initial Date of Rank dated 30 September 2019, is amended to reflect: Block B "00 years, 06 months, and 00 days" vice "00 years, 00 months, and 00 days" and Block E "2019 01 19" vice "2019 07 19."

Petitioner's NAVPERS 1000/4, Officer Appointment Acceptance and Oath of Office dated 30 September 2019, is modified to reflect: Blocks 19 and 2 "2019 01 19" vice "2019 07 19".

Petitioner's promotion to Lieutenant Junior Grade/O-2 effective date is changed to "2021 01 19" vice "2021 07 19".

Defense Finance and Accounting Service will complete an audit of Petitioner's records to determine retroactive pay and allowance entitlement.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
