- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to reflect declined participation in the Survivor Benefit Plan (SBP).
- 2. The Board, consisting of part of the state of the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, she exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:
- a. In accordance with reference (b), SBP elections must be made prior to retired pay becoming payable and the election to participate in or decline SBP is irrevocable. Reference (c), Section V (SBP Spouse Concurrence) specifies "The date of the spouse's signature in item 41c MUST NOT be before the date of the member's signature in Block 39c, or on or after the date of retirement listed in Part I, Section I, Block 4."
 - b. Petitioner married on 17 January 2006.

(2) Subject's naval record

- c. On 6 May 2020, Petitioner's spouse signed DD Form 2656, Data for Payment of Retired Personnel before a notary witness "concurring with the SBP election" made by her spouse.
- d. On 7 May 2020, Petitioner signed DD Form 2656, Data for Payment of Retired Personnel electing not to participate in SBP.

- e. Petitioner transferred to the Fleet Reserve effective 1 October 2020 and was automatically enrolled in SBP Spouse coverage but a beneficiary is not identified in HUNT system.
- f. On 23 November 2020, Defense Finance and Accounting Service (DFAS) informed Petitioner of SBP coverage defaulted to automatic coverage because they "did not receive DD Form 2656 or election could not be processed because your from was no valid."
- g. On 8 October 2021, Petitioner and spouse signed SBP Affidavit before a notary witness electing to decline SBP coverage.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded Petitioner provided sufficient evidence to reflect her and spouse's desire to decline SBP coverage prior to transferring to the Fleet Reserve. Although Petitioner did not complete the proper administrative requirements, the Board felt that under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner elected to decline participation in SBP with spouse concurrence prior to transferring to the Fleet Reserve effective 1 October 2020.

Note: Defense Finance and Accounting Service will complete an audit of Petitioner's pay records to determine the amount of premium refund.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
