1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected by removing an Administrative Remarks 6105 (Page 11) counseling, enclosure (2), from her official military personnel file (OMPF).

2. The Board, consisting of █, █, and █, reviewed Petitioner's allegations of error and injustice on 12 October 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulation within the Department of the Navy.

b. Petitioner received enclosure (2) on 16 August 2019 for violating Government Travel Charge Card (GTCC) policies and procedures due to an unauthorized charge on 17 July 2019 while not in a TAD status. Petitioner contends enclosure (2) is unjust as she accidentally used the GTCC. While TAD in April 2019, Petitioner used the application Uber Eats to order food and used her GTCC. Unbeknownst to her, the application saves the credit card information, and the credit card becomes the default payment method. In July 2019, a family member used Petitioner's phone to purchase food via the Uber Eats application and the GTCC was charged. Petitioner included with her petition a letter from the commanding officer (CO) who issued the Page 11, enclosure (3). The CO requested removal of the Page 11 based on further review of the circumstances.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board determined that Petitioner's request warrants relief. The Board noted that Petitioner inadvertently used the GTCC and that the CO was convinced that issuing the Page 11 was erroneous. Consequently, the Board found the 6105 unjust and concluded that Petitioner's Page 11 entry, enclosure (2) shall be removed.

RECOMMENDATION

In view of the above, the Board recommends the following corrective action.

Remove Petitioner's 6105 counseling entry dated 16 August 2019.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
