1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected show Petitioner's current reenlistment contract reflects inactive status vice active.

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 7 October 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. 27 January 2011, Petitioner enlisted for 8 years in the U.S. Naval Reserve with an expiration of obligated service (EOS) of 26 January 2019.

c. On 2 August 2011, Petitioner entered active duty for 4 years with an end of active obligated service (EAOS) of 1 August 2015 and soft end of active obligated service (SEAOS) of 1 August 2016.

d. On 1 August 2016, Petitioner was released from active duty and transferred to the Navy Reserve after completing required active service.

e. On 20 January 2019, Petitioner reenlisted for 2 years.

f. On 5 August 2020, Petitioner was issued official active duty for operational support orders. Petitioner was ordered to report for active duty for special work under the authority of Title 10 USC section 12301 (D), for the period of 1 October 2020 to 30 September 2021. Depart place from which called (or ordered) to active duty (PLEAD) NET 1 October 2020.

g. On 14 September 2020, Petitioner signed a command career request (NPPSC 1160/1) requesting a 2-year reenlistment effective 1 December 2020 in the U.S. Naval Reserve, and was approved by cognizant authority on 4 December 2020.

h. On 18 December 2020, Petitioner reenlisted for 2 years with an EOS of 17 December 2022. Petitioner's immediate reenlistment contract listed status: active and Reserve Active Duty Obligation (RADO) months/days: 024/000.

i. On 2 September 2021, Petitioner was issued official active duty for operational support orders. Petitioner was ordered to report for active duty for operational support under the authority of Title 10 USC section 12301 (D), for the period of 1 October 2021 to 1 July 2022. Depart place from which called (or ordered) to active duty (PLEAD) NET 1 October 2021.

j. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that due to administrative error, Petitioner's reenlistment contract was marked as "active" rather than "inactive." Petitioner was erroneously considered as Full Time Support.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 2-year immediate reenlistment contract (NAVPERS 1070/601) executed on 18 December 2020 listed status: inactive vice active.

Note: Petitioner's RADO and special program indicator may require updating that is appropriate to Petitioner's current status.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
