Subj: REVIEW OF NAVAL RECORD ICO XXX-XX- USN RET,

1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to establish eligibility to transfer Post-9/11 GI Bill education benefits to eligible dependents.

2. The Board, consisting of **Construction**, **Construction**, and **Construction**, reviewed Petitioner's allegations of error and injustice on 17 November 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, she exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. The Post-9/11 Veterans Educational Assistance Act (Post-9/11 GI Bill, Public Law 110-252) was signed into law on 30 June 2008 and became effective on 1 August 2009. The bill provides financial support for education and housing for service members with at least 90 days of service on or after 11 September 2001. The act also includes provision for qualifying service members to transfer education benefits to their eligible dependents. General descriptions of the essential components of the law were widely available beginning in summer 2008 but specific implementing guidance was not published until summer 2009.

b. In accordance with reference (b), the option to transfer a Service member's unused education benefits to an eligible dependent required a 4-year additional service obligation at the time of election for those eligible to retire on or after 1 August 2012. Additionally, all officers

were required to have a NAVPERS 1070/613, Administrative Remarks, prepared by their command in the Navy Standard Integrated Personnel System Electronic Service Record (ESR), agreeing to serve the required additional years of service prior to initiating their electronic transfer election via the MilConnect Transfer of Education Benefits (TEB) portal. Furthermore, the policy directed members to periodically check the status of their application. If the request was disapproved, members were required to take corrective action and reapply with a new service obligation end date.

c. Petitioner Active Duty Service Date was 26 May 1993.

d. Petitioner submitted TEB application on 12 November 2009. The Service rejected the application indicating, "Service Member has not committed to the required additional service time."

e. On 16 November 2009, Petitioner signed "Post 9/11 GI Bill" NAVPERS 1070/613, Administrative Remarks; however, it was not entered into her ESR.

f. On 21 December 2020, "Additional Service Obligation for Transfer of Post-9/11 GI Bill Benefits" NAVPERS 1070/613, Administrative Remarks was entered into Petitioner's ESR with a note indicating "member submitted request in 2009 but was denied due to Command at the time not creating Page 13."

g. Petitioner transferred to the Retired List effective 1 October 2021.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. Petitioner met the basic eligibility criteria to transfer Post-9/11 GI Bill education benefits but failed to complete the administrative requirements outlined in reference (b). Although Petitioner did not complete the proper administrative requirements, the Board determined, she exhibited intent to transfer education benefits and served over 11-years after initiating the electronic transfer election, thereby meeting the spirit and intent of the 4-year additional service obligation outlined in reference (c). Therefore, the Board felt under these circumstances, relief if warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner, in coordination with her command completed the required NAVPERS 1070/613, Administrative Remarks on 12 November 2009 and submitted it to Commander, Navy Personnel Command for inclusion in the Petitioner's Official Military Personnel File.

Petitioner elected to transfer unused education benefits to /18-months and /18-months through the MilConnect TEB portal on 12 November 2009.
