1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to Petitioner's household goods (HHG) shipping entitlement.

2. The Board, consisting of █ and █ reviewed Petitioner's allegations of error and injustice on 22 June 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 12 February 2020, Petitioner was issued release from active duty orders.

c. On 30 April 2020, Petitioner was transferred to the Fleet Marine Corps Reserve.

d. On 1 February 2021, Petitioner was paid final travel pay from █ to █

e. On 29 April 2021, Petitioner submitted a request to Headquarters Marine Corps (LPD) to request an extension of the household goods shipping entitlement.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board agreed that Petitioner was unaware that if his travel and transportation allowances were paid without utilizing his HHG shipping entitlement that his home of selection is irrevocable, in accordance with paragraph 051003-B Note of reference (b). The Board agreed that HQMC (LPD) will adjudicate the travel and transportation extension request.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's Disbursing Office (DO) voucher number 811085 is null and void. Note: Petitioner will be issued a debt in the amount of \$170.21.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
