1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish retroactive advancement to Logistics Specialist First Class (LS1)/E-6 from the February 2020 (Cycle 106) Navy Wide Advancement Exam (NWAE).

2. The Board, consisting of █, █, and █, reviewed Petitioner's allegations of error and injustice on 23 November 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. In accordance with reference (b), standard score comparison exception to policy request must be sent to Director, Military Personnel Plans and Policy (N13) no later than 6 months after the missed exam's limiting date. Request submitted later than 6 months are redirected to the Board. Limiting date for the February advancement cycle is 31 December of the same year and August advancement cycle is 30 June of the next year.

b. On 28 November 2018, Petitioner issued BUPERS Mobilization Order: █. Petitioner executed the mobilization orders in support of █ from 10 May 2019 through 26 June 2020; boots on ground 26 August 2019 through 12 April 2020.

c. Petitioner participated in September 2020 (Cycle 107) NWAE and passed not advanced.

d. Petitioner transferred to the Retired Reserve without pay effective 1 July 2021.

e. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

#### CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. Petitioner met the criteria for standard score comparison in accordance with reference (b). The Board determined after comparing the September 2020 (Cycle 107) NWAE to August 2019 (Cycle 105) and February 2020 (Cycle 106) NWAE the Petitioner's final multiple score (FMS) did not meet the minimum multiple required for Cycle 105 but did exceed the minimum for Cycle 106. Therefore, the Board felt, under these circumstances, relief is warranted.

#### RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's September 2020 (Cycle 107) NWAE was compared to the missed February 2020 (Cycle 106) LS1/E-6 NWAE. Petitioner's FMS for Cycle 106 was 104.24; the Minimum Multiple Required was 99.30.

Petitioner advanced to LS1/E-6 effective 16 November 2020 with a time and rate date of 1 July 2020.

Petitioner's Retirement Order and Transfer Authorization to Retired Reserve Status effective 1 July 2021 and Certificate of Retirement are modified to reflect "LS1" vice "LS2."

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
