1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting his naval record be corrected to show Petitioner reenlisted on 14 May 2021, and was eligible for and received a Selective Reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED], reviewed Petitioner's allegations of error and injustice on 23 November 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 19 September 2016, Petitioner entered active duty with an End of Active Obligated Service (EAOS) of 18 September 2020 and Soft End of Active Obligated Service (SEAOS) of 18 September 2021.

c. In accordance with reference (b), this NAVADMIN announces revised SRB policy for Active Component (AC) and Full-Time Support (FTS), superseding NAVADMIN 272/19. Sailors must now reenlist within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who can reenlist at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

d. On 1 June 2020, Deputy Chief of Naval Personnel notified Petitioner that he was authorized immediate in-rate reenlistment in the Active Component (AC) with an end date of September 2021.

e. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 003/FY21) listed a zone "A" SRB with an award level of 3.5 (\$60,000 award ceiling) for the ETV rate.

f. On 1 March 2021, Petitioner signed a Command Career Request (NPPSC 1160/1) for a 4 year reenlistment effective 30 April 2021, and was approved by cognizant authority on 21 March 2021.

g. On 29 April 2021, COMNAVPERSCOM notified command that Petitioner's SRB had been approved for a 4 year reenlistment effective 14 May 2021 for a zone "A" SRB with an award level of 3.5 for the ETV rate.

h. On 30 April 2021, Petitioner reenlisted for 4 years with an EAOS of 29 April 2025.

i. On 14 May 2021, Petitioner was advanced to Petty Officer Second Class/E-5.

j. On 25 May 2021, COMNAVPERSCOM notified Petitioner's command that SRB was cancelled.

k. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Petitioner's reenlistment contract was erroneously processed as a 4-year term reenlistment for a date of 30 April 2021, resulting in the cancellation of the SRB authorization.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was discharged and reenlisted on 13/14 May 2021, vice on 29/30 April 2021 for a term of 4 years.

Note: This change will entitle the member to a zone "A" SRB with an award level of 3.5 (\$60,000 dollar award ceiling) for the [REDACTED] rate. Remaining obligated service to 18 September 2021 will be deducted from SRB computation.
