1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting his naval record be corrected to show Petitioner reenlisted on 18 June 2021 for 6 years vice 5 years and was eligible for and received a Selective reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED], reviewed Petitioner's allegations of error and injustice on 23 November 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 9 October 2007, Petitioner entered active duty.

c. On 7 October 2015, Petitioner reenlisted for 6 years with an End of Active Obligated Service (EAOS) of 6 October 2021.

d. In accordance with reference (b), this NAVADMIN announces revised SRB policy for Active Component (AC) and Full-Time Support (FTS), superseding NAVADMIN 272/19. Sailors must now reenlist within 365-days of their EAOS (as opposed to 270-days required in

NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who can reenlist at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

e. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 003/FY21) listed a zone “C” SRB with an award level of 6.5 (\$100,000 award ceiling) for the SB/O52A rate/NEC.

f. On 11 May 2021, Petitioner signed a Command Career Request (NPPSC 1160/1) for a 5 year reenlistment effective 18 June 2021, and was approved by cognizant authority on 15 June 2021.

g. On 3 June 2021, COMNAVPERSCOM notified command that Petitioner’s SRB had been approved for a 6 year reenlistment effective 18 June 2021 for a zone “C” SRB with an award level of 6.5 for the SB/O52A rate/NEC.

h. On 18 June 2021, Petitioner reenlisted for 5 years with an EAOS of 17 June 2026.

i. On 27 July 2021, Deputy Chief of Naval Personnel notified Petitioner that he was authorized immediate in-rate reenlistment in the Active Component (AC) with an end date of December 2021.

j. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner’s application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Petitioner was approved for a Zone C, SB/O52A, 6.5 award level SRB upon executing a 6-year term reenlistment on 18 June 2021, however, Petitioner reenlisted for a term of only 5 years, making him ineligible to receive the SRB. Furthermore, Petitioner’s reenlistment request was not approved until 27 July 2021, making him ineligible to reenlist on 18 June 2021.

RECOMMENDATION

That Petitioner’s naval record be corrected, where appropriate, to show that:

The immediate reenlistment contract (NAVPERS 1070/601) executed on 18 June 2021 was for a term of 6 years, vice 5 years.

Note: This change will entitle the member to a zone “C” SRB with an award level of 6.5 (\$100,000 award ceiling) for the SB/O52A rate/NEC. Remaining obligated service to 6 October 2021 will be deducted from SRB computation.

A copy of this Report of Proceedings will be filed in Petitioner’s naval record.
