1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to change his narrative reason for separation and reenlistment code in accordance with reference (c). Enclosure (2) applies.

2. The Board consisting of ██████████ and ██████████ reviewed Petitioner's allegations of error and injustice on 8 October 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies, to include the 25 July 2018 guidance from the Under Secretary of Defense for Personnel and Readiness regarding equity, injustice or clemency determinations (Wilkie Memo).

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to review the application on its merits.

c. Petitioner enlisted in the Navy and began a period of active service on 27 June 2005.

d. On 30 January 2006, Petitioner submitted an admission of his homosexuality. On

7 February 2006, Petitioner submitted a request to the separation authority to be issued an honorable discharge.

e. On 9 February 2006, Petitioner was notified of the initiation of the initiation of administrative separation proceedings by reason of misconduct due to homosexual conduct, at which point, Petitioner exercised his right to consult with counsel, and waived his right to a hearing before an administrative discharge board (ADB).

f. On 13 February 2006, Petitioner received a second notification of the initiation of the initiation of administrative separation proceedings by reason of misconduct due to homosexual conduct, at which point, Petitioner elected his right to consult with counsel, and waived his right to a hearing before an administrative discharge board (ADB).

g. On 17 February 2006, Petitioner's commanding officer recommended Petitioner's discharge with an honorable character of service by reason of homosexual conduct.

h. Subsequently, on 13 March 2006, the discharge authority approved and directed Petitioner's discharge. On 28 March 2006, Petitioner was discharged with an honorable character of service by reason of homosexual admission, and issued an RE-4 reentry code.

i. References (b) and (c) set forth the Department of the Navy's current policies, standards, and procedures for correction of military records following the "don't ask, don't tell" (DADT) repeal of 10 U.S.C. 654. It provides service Discharge Review Boards with the guidance to grant requests to change the characterization of service to "honorable," narrative reason for discharge to "secretarial authority," SPD code to "JFF," and reentry code to "RE-1J," when the original discharge was based solely on DADT or a similar policy in place prior to enactment of it and there are no aggravating factors in the record, such as misconduct.

j. Petitioner contends his record should be corrected because he served with distinction and does not deserve anything less reflected on his DD Form 214.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of references (b) and (c), the Board concludes that Petitioner's request warrants relief. In this regard, the Board noted Petitioner's overall record of military service and current Department of the Navy policy.

In view of the above, the Board directs the following corrective action.

RECOMMENDATION:

That Petitioner's be issued a new Certificate of Release or Discharge from Active Duty (DD Form 214) indicating "secretarial authority" narrative reason for separation, "RE-1J" reenlistment code, "JFF" separation code, and "MILPERSMAN 1910-164" separation authority. That a copy of this report of proceedings be filed in Petitioner's naval record.
