1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner was eligible for and received a Selective Reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED], reviewed Petitioner's allegations of error and injustice on 2 December 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 1 July 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 30 June 2019.

c. On 17 April 2018, Petitioner signed an agreement to extend enlistment for 17 months with an Soft End of Active Obligated Service (SEAOS) of 30 November 2020 in order to extend to match EAOS with Projected Rotation Date (PRD) of November 2020.

d. In accordance with reference (b) [15 April 2020], this NAVADMIN announces revised SRB policy for Active Component (AC) and Full-Time Support (FTS), superseding NAVADMIN 272/19. Sailors must now reenlist within 365-days of their EAOS (as opposed to 270-days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who can reenlist at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

e. On 21 July 2020, Petitioner signed an agreement to extend enlistment for 12 months with an SEAOS of 30 November 2021 in order to extend to match EAOS with PRD of November 2021.

f. On 25 June 2021, Petitioner signed a Command Career Request (NPPSC 1160/1) for a 3 year reenlistment effective 20 August 2021, and was approved by cognizant authority on 28 June 2021.

g. In accordance with reference (c) [29 June 2021], FY21 SRB Award Plan (N13SRB 004/FY21) listed a zone "B" SRB with an award level of 0.5 (\$30,000 award ceiling) for the DC rate.

h. In accordance with reference (d) [9 August 2021], FY21 SRB Award Plan (N13SRB 005/FY21) listed a zone "B" SRB with an award level of 0.5 (\$30,000 award ceiling) for the DC rate.

i. On 20 August 2021, Petitioner reenlisted for 3 years with an EAOS of 19 August 2024.

j. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that at the time of his reenlistment, his EAOS date was 30 November 2021. If the Command Career Counselor had submitted the SRB precertification 35 to 120 days in advance of Petitioner's reenlistment date, he would have been approved for an SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's command submitted an Officer Personnel Information System (OPINS)/Navy Standard Integrated Personnel System (NSIPS) request 35 to 120 days in advance of the requested reenlistment date for the Sailor, and was approved by cognizant authority.

Note: This change will entitle the member to a zone "B" SRB with an award level of 0.5 (\$30,000 award ceiling) for the DC rate. Remaining obligated service to 30 November 2021 will be deducted from SRB computation.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
