| 2. The Board, consisting of particle, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies. | |
| 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings: | |
| a.] | Petitioner graduated from Institute on December 2015. |

c. On 12 March 2020, Hospital Corpsman Community Manager notified Navy Recruiting Command that based on what was provided, Petitioner was eligible to enlist as a "HM 4yo L29A" and "upon completion of HM A school can be promoted to E4" because there was no evidence of supervisory experience required for advancement to E-5.

E-3 with 4-years considered active duty obligation.

b. On 9 September 2019, Petitioner enlisted in Naval Reserve for 8-years in the pay grade

- d. On 16 March 2020, Commander, Navy Recruiting Command (CNRC) approved Petitioner for advancement to Hospital Corpsman Third Class "(HM3)/E-4 (L29A Mortician) upon completion of Hospital Corpsman (HM) class "A" school."
 - e. On 15 July 2020, Petitioner reclassified and issued Annex "C" and entered active duty.
- f. On 25 February 2021, Petitioner completed Hospital Corpsman Basic and is advanced to HM3/E-4.
- g. On 29 July 2021, ______, Inc. confirmed Petitioner's employment from May 2019 to June 2020 as a Funeral Director Supervisor/Embalmer and outlined her areas of responsibility while employed there.
- h. On 1 September 2021, ________, Inc. confirmed Petitioner's employment from 2014 while attending mortuary school, and became a supervisor in 2017 until her departure in 2019. The letter also provide Petitioner's main duties during her employment.
- i. On 17 February 2022, HM Enlisted Community Manager confirmed Petitioner's record should reflect earning NEC L29A effective date of graduation from HM class "A" school and will ensure the NEC is updated accordingly.
- j. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. In accordance with reference (b), Petitioner met the eligibility requirements for advancement to HM2/E-5 and awarding of NEC L29A upon completion of HM class "A" school. The Board concluded verification of Petitioner's supervisory work experience was not obtained prior to her accession date, thereby impeding her advancement to HM2/E-5. Although the proper administrative requirements were not completed, the Board felt that under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner advanced to "HM2/E-5" vice "HM3/E-4" effective 25 February 2021 with a time in rate of 1 January 2021.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
