- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to restore anniversary year 2020 to a satisfactory year.
- 2. The Board, consisting of property and provided peritioner's allegations of error and injustice on 30 November 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:
- a. In accordance with reference (b), the full-year period used for crediting of qualifying years for non-regular retirement is based on anniversary years. The anniversary year is calculated from an anniversary date, which is established on the day the Marine entered into active service, or active status in the Reserve Component.
- b. On 4 November 2008, Petitioner enlisted in the Marine Corps Reserve and entered the Navy Reserve Officer Training Corps (NROTC).
 - c. On 13 May 2011, Petitioner completed NROTC.
 - d. On 14 May 2011, Petitioner was commissioned.

- e. On 31 August 2017, Petitioner was released from active duty and transferred to the Marine Corps Reserve.
 - f. In 2021, Petitioner's anniversary date was changed from 4 November to 14 May.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board determined the Service's administrative correction to the Petitioner's anniversary date was appropriate in accordance with reference (b). However, the Board concluded the administrative correction created an unsatisfactory year for anniversary year ending 13 May 2020. Therefore, the Board felt under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Five (5) Inactive Duty Training points was transferred from anniversary year ending 13 May 2019 to the anniversary year ending 13 May 2020.

Note: This change will result in a satisfactory year of service for anniversary year ending 13 May 2020.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
