1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting her naval record be corrected by updating her Navy Wide Advancement Exam (NWAE) Cycle 246 profile sheet.

2. The Board, consisting of █, █, and █, reviewed Petitioner's allegations of error and injustice on 6 January 2022 and, pursuant to its regulations, determined the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulation within the Department of the Navy.

b. Petitioner contends she completed the Professional Military Knowledge Eligibility Exam (PMK-EE) for E7 on 10 August 2019 but the Navy E-learning system did not project her correct passing grade. As a result, her profile sheet for Cycle 246 was annotated as "invalidated" and per the Naval Education and Training Professional Development Center (NETPDC), direction by the Board is required in order to correct and/or validate the Cycle 246 profile sheet.

c. In an advisory opinion (AO) at enclosure (2), the Navy Personnel Command, Enlisted Career Progression Division (PERS 803) recommends Petitioner's NWAE Cycle 246 profile sheet be re-validated.

## CONCLUSION

Upon review and consideration of all the evidence of record, the Board determined Petitioner's request warrants relief. The Board, relying on enclosure (2), concluded Petitioner's NWAE Cycle 246 profile sheet should be "re-validated" as recommended by PERS-803.

## RECOMMENDATION

In view of the above, the Board directs the following corrective action.

Petitioner's naval record be corrected by re-validating her NWAE Cycle 246 profile sheet, as recommended by enclosure (2).

Any material or entries inconsistent with or relating to the Board's recommendation be corrected, removed, or completely expunged from Petitioner's record, and that no such entries or material be added to the record in the future. This includes, but is not limited to, all information systems or database entries that reference or discuss the expunged material.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
