1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner reenlisted on 3 October 20201 and was eligible for and received a Selective Reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED] and [REDACTED] reviewed Petitioner's allegations of error and injustice on 9 December 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 9 August 2017, Petitioner enlisted in the U.S. Naval Reserve for 8 years with an EOS of 8 August 2025. Furthermore, Petitioner signed an Enlistment Guarantees (NAVCRUIT 1133/52) Annex "A" to DD Form 4 dated 9 August 2017 listing the following options: Aviation Structural Mechanic (AM/5YO) Class "A" School Guarantee (T+X).

c. On 25 August 2017, Petitioner signed an Enlistment Guarantees (NAVCRUIT 1133/52) Annex "B" to DD Form 4 dated 9 August 2017 listing the following options: Advanced Technical Field Special Warfare Operator (ATF/SO 6YO) Challenge Program.

d. On 4 October 2017, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 3 October 2021 and Soft End of Active Obligated Service (SEAOS) of 3 October 2023.

e. On 29 June 2020, Petitioner was issued official change duty orders (BUPERS order: 1810), while stationed in [REDACTED] with an effective date of departure of July 2020. Ultimate activity was [REDACTED] for duty with an effective date of arrival of 5 December 2020.

f. On 9 September 2020, Petitioner was issued official modification to change duty orders (BUPERS order: 1810), while stationed in [REDACTED] with an effective date of departure of July 2020. Ultimate activity was [REDACTED] for duty with an effective date of arrival of 5 December 2020.

g. In accordance with reference (b) [9 August 2021], FY21 SRB Award Plan (N13SRB 005/FY21) listed a zone "A" SRB with an award level of 4.5 (\$45,000 award ceiling) for the EOD/M02A rate/NEC.

h. On 13 August 2021, Petitioner signed a Command Career Request (NPPSC 1160/1) for a 4 year reenlistment effective 3 October 2021, and was approved by cognizant authority on 17 August 2021.

i. On 29 September 2021, Petitioner earned NEC M02A (Basic EOD Technician).

j. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Petitioner was approved to reenlist for SRB for a term of 4 years on 3 October 2021. Due to no fault of the Petitioner, the Personnel Support Detachment was unable to create the reenlistment contract prior to the scheduled reenlistment date and the Petitioner's extension became operative.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

The Petitioner was discharged on 2 October 2021 and reenlisted on 3 October 2021 for a term of 4 years.

Note: This change will entitle the member to a zone "A" SRB with an award level of 4.5 (\$45,000 award ceiling) for the EOD/M02A rate/NEC.
